The First-Year Law Students' Examination, or "baby bar," is a one-day test given remotely in June and November. Not all law students have to take the baby bar. Law students completing their first year of law study in a juris doctor degree program at a State Bar-unaccredited registered law school, through the Law Office Study Program and those without two years of college work attending a Committee of Bar Examiners- or an American Bar Association-accredited law school must take the First-Year ...

First-Year Law Students' Examination - State Bar of California

Students must pass the baby bar within three administrations of the test after they first become eligible upon their completion of the first year of law school. Failing to do so can result in loss of the credits for legal study accrued prior to the baby bar. If you pass the baby bar outside of this window only one year of law study credit is granted toward the legal education requirements necessary to qualify for the California Bar Exam.

The baby bar is another name for the First-Year Law Students' Examination (FYLSE). It is administered by the State Bar of California in both June and October each year. Not everyone has to take the baby bar exam! It is primarily administered to those who study law at unaccredited law schools (including online law schools).
